SECTION 4 – FIRST AID MEASURES

Inhalation:	Keep calm and remove affected persons into fresh air and keep warm and at rest.

SECTION 5 – FIRE FIGHTING MEASURES

Fire/Explosion Hazards

Non-combustible material. The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases.

Extinguishing Media

Extinguish fire using resistant foam, dry chemical, carbon dioxide or foam/water fog. Try to contain spills and minimise spillage entering drains or water courses.

Precautions for fire fighters

Fire fighters must use self-contained breathing apparatus. Evacuate the area and fight fire from a safe distance. There is little danger of violent reaction or explosion if significant quantities of this product are involved in a fire.

SECTION 6 – ACCIDENTAL RELEASE MEASURES

Spills and Disposal

Ensure suitable personal protection (including respiratory protection) during removal of spillage. Contain the spill to prevent any further contamination of soil or atmosphere. Stop the source of the spill immediately, if safe to do so. Collect as much of the spill as possible with a suitable absorbent material and place into suitable container for disposal. Decontaminate spill area with detergent and water.

Spills in water: In the event of a major spill, prevent spillage from entering drains or sanitary sewer system. If product contaminates rivers and lakes or drains inform respective authorities.

SECTION 7 – HANDLING AND STORAGE

Handling

It is recommended to avoid physical contact with the product and to have adequate ventilation. Avoid spillage into the eyes, or contact with bare skin or clothing. Avoid dust formation. Wash hands, feet, face thoroughly after handling. Remove contaminated clothing immediately. When

opening, point the container away from the face and body. These precautions will also reduce the risk of exposure.

Storage

The product is stable under normal conditions of storage. Keep container lids tightly closed, in a dry, well-ventilated area away from direct sunlight. Label clearly as a pesticide storage area. Do not store in buildings inhabited by humans or animals.

Health Effects

Inhalation:	It is not expected to be harmful through inhalation and unlikely to cause any discomfort or irritation.

Eye contact: Ingestion:	It may be irritating to eyes with mild discomfort. Significant oral exposure is considered to be unlikely.
